Superintendent Updates:

- CMS unlikely to approve the 2024 deadline request instead requiring 2019 as the deadline to have compliance with conflict of interest. They are likely to approve a compliance plan submittal in 2019.
- Disenrollment of waivers on enrollees who have not used waiver services in one year or more

- Best Buddies International now has an Ohio Chapter with permanent office space in Columbus. Next step will be to help chapters form throughout Ohio.
- Received an email specific to information regarding the process to award/approve Medicaid numbers for new providers

OLD BUSINESS:

Lori Moore, Business Director informed the board of project updates.

- Putting grab bars, additional electrical socket, heater and sealing outside walls in the new FPI Bathroom
- Sandy has met with three HVAC Contractors Johnson Control, General Temperature Control and Trame for quotes at both Starting Gate and FPI
- Spot check Inspection of buses and replaced tires on some vehicles. Annual inspection is April 20.
- Paid the bid permit fees on the documents for renovation project at ECFC for the new EI space

- Special Fayette County Board meeting on March 21st at 7:15 am to select a contractor for the renovation of Starting Gate

Lori Moore, Business Director gave an update on the maintenance discussion with Metropolitan Housing.

• Sent contract over two weeks ago and the revised copy on Friday, March 4. We are waiting on a response from Metropolitan Housing.

Lori Moore, Business Director presented a presentation on the repair costs for Starting Gate since 2007. Total maintenance costs have been \$260,357 in repairs

NEW BUSINESS:

Suzie Janasov, Early Childhood Service Director informed the board of the Step up to Quality Audit

• Ohio Department of Education has had many issues in setting up the portal to enter the required information.

- We have been gathering enormous amounts of data needed to submit to the state. The team has met to go over fiscal, HR, building security in addition to all the classroom information that is gathered by all the preschool teachers and aides.
- We have attended work sessions at Hopewell to ask any needed questions
- There is a list of several Developmental Disability preschools in the state that are having some of the same barriers with the ODE system.

Lori Moore, Business Director asked the FCBDD for permission to sell obsolete telephones.

 According to ORC 307.12 if fair market value of the property to be sole or donated under his division is in the opinion of the board, two thousand five hundred dollars or less, the board may do either of the following: (1) Sell the property by private sale, without advertisement or public notification; (2) Donate the property to an eligible nonprofit organization that is located in this state and is exempt from federal income taxation pursuant to 26 U.S.C. 501(a) and (c) (3).
