

### Fayette Progressive Preschool Continues to Implement the PBIS Approach


The Positive Behavioral Interventions and Supports (PBIS) program is an evidence-based three-tiered framework to improve and integrate all of the data, systems and practices affecting student outcomes every day. PBIS creates schools where all students succeed. Fayette Progressive Preschool is focusing on different ways to incorporate this framework into the day to day functions of the preschool to ensure all students are successful in their educational experience. The PBIS is based on the follow three tiers:

Tier 1: Tier 1 practices and systems establish a foundation of regular, proactive support while preventing unwanted behaviors. Schools provide these universal supports to all students, school wide.

Tier 2: Tier 2 practices and systems support students who are at risk for developing more serious problem behaviors before those behaviors start. These supports help students develop the skills they need to benefit from core programs at the school.

Tier 3: At Tier 3, students receive more intensive, individualized support to improve their behavioral and academic outcomes. At this level, schools rely on formal assessments to determine a student's needs.

On June 23<sup>rd</sup>, The Ohio Department of Developmental Disabilities hosted a "virtual" Transformation Summit. The purpose of the Summit was to connect County Boards, providers, families and people served with resources and discussions around the transformation of services for people with disabilities, including employment, transition services and adult day services.

The Family Outreach and Communication Grant that FCBDD participates in along with Ross and Pickaway Counties was highlighted at the Summit. The purpose of this grant is to increase counties efforts in communicating with families and people served with employment, transition services and meaningful day activities that connect people to community opportunities instead of segregated services.

Fayette County Board of DD's SSA Cheryl Binegar was asked to present at the virtual summit about the grant in a breakout session. She was able to present what the committee has been working on to various stakeholders and increase their knowledge of the efforts around the state to make these changes.





The Fayette County Dragons Special Olympics team is currently working on plans to stay active during Covid-19. We are continuing to abide by the State mandates set forth with social distancing which brings a challenge to what can and can't be done. We are working diligently to come up with a solution to keep our athletes involved and will release info as soon as possible.

# **811 Rental Assistance Program**

Ohio has a rental assistance program for people with developmental disabilities called the 811 Rental Assistance Program, that ensures access to affordable housing. Along with the affordability, if a person has paid supports to assist them in living in their apartment, these units allow for that help to come in as needed. Fayette County is fortunate to have apartment units available in the Washington Court House and Jeffersonville area.

## DD Advocacy and Awareness Day 2020

On March 4<sup>th</sup>, five advocates from Fayette County chose to attend the 2020 Developmental Advocacy and Awareness Day. The event has taken place at the Ohio State House for more than a decade. The theme this year was Live, Work and Go where we want.

This event is funded by a grant from The Ohio Developmental Disabilities Council's (ODDC). ODDC is one of a national network of state councils, committed to self-determination and community inclusion for people with developmental disabilities. One of Council's goals is to educate policymakers about how state government services and policies can be improved, expanded, or strengthened on behalf of people with disabilities. Council believes it is important for the policymakers of Ohio to hear the voices of people with disabilities and their families through this event.

The annual event opened with Emcee, Shari Cooper. Guests speakers, Patti Ruble shared how she helped others to " **LIVE** within their communities". Joseph Trisler spoke about **WORK**, he has a full-time job and has his own side business.
Joseph is proof that a diagnosis does not have to mean disaster. **Go**, Nick Comstock shared his story of "breaking out of his cell", when he wanted to go to McDonald's but didn't have transportation to get him there. Nick is working with the Empowerment Center for People with disabilities on an initiative called the Family Network Project. This project is designed to help people with disabilities and their families become more integrated with the folks in their communities.

After the rally in the Atrium, the Fayette County constituents took the opportunity to meet with Representative Gary Scherer and Senator Bob Peterson's, legislative aids. During the meeting, the people advocated for the right to **Live** where they want, **Work** where they want, and **Go** where they want to go. One advocate stated, "I am happy where I live now, to have some independence, but I still need some support. I appreciate the work that has been done for the Direct Service Professionals, giving them more money, but I still think that there is more to do. A staff person told me, that if it wasn't for the food bank, they would not have been able to afford Christmas dinner. That is why I think we still need to find a way to pay the Direct Support Professionals more money." The people also wanted to share a positive thought, "transportation is improving some, within Fayette County, offering more stops to the deviated route, and we really appreciate that." Fayette County advocates wanted to make sure that the legislatures knew that the work that they have done thus far is appreciated. Another point of discussion was employment. Advocates would like to see more employer incentives, to encourage businesses to consider hiring people with disabilities. At the end of the meeting, Senator Peterson was able to meet with his constituents and talk with them briefly and thanked them for coming and sharing their concerns.
